
I am Carroll Evans Cox I reside in Mililani, Hawaii. I am the founder and president of EnviroWatch Inc. I am also owner and producer of THE CARROLL COX SHOW. The show airs live on Sundays 8-9 am on the radio dial at 1080 AM. I am submitting this letter to request that your office investigate the travel, acceptance of gifts and the reporting of the gifts by Hawaii's Lt. Governor Duke Aiona. More specifically, Lt. Governor Aiona accepted airfare, related to travel to Argentina, and conference registration from United In Prayer, an organization based in Hawaii, and Mr. Miles Kawakami and Mr. Lon Briggs private citizens who is conducting business in the state of Hawaii. Lt. Governor Aiona also accepted gifts exceeding \$200.00 from some or all of these entities for himself and his wife Mrs. Vivian Aiona.

I believe that the purpose of the travel and gifts does not meet and is in direct conflict with the thresh hold for conditions established in the State of Hawaii's Code of Ethics. Again, I am respectfully submitting this letter to memorialize my formal request to have the Hawaii State Ethics Commission investigate this matter. I also believe that the nature of the travel and the participation in the religious conference did not benefit the people of the State of Hawaii and served only to personally benefit Lt. Governor Duke Aiona and his wife Mrs. Vivian Aiona, and violates the separation of church and state.
