RESOLUTION

SUPPORTING THE UTILIZATION OF RECYCLED WATER FOR INDUSTRIAL USES AT THE CITY'S WASTE-TO-ENERGY (H-POWER) FACILITY.

WHEREAS, of the 1.6 million tons of waste generated annually on Oahu, about 600,000 tons of this waste is burned at H-Power, the city's waste-to-energy facility; and

WHEREAS, about five percent of the island's electricity is produced at the H-Power plant; and

WHEREAS, H-Power consists of two furnace/boilers which can burn 854 tonsper-day of refuse-derived fuel (RDF) at temperatures exceeding 1,800 degrees Fahrenheit; and

WHEREAS, at present, H-Power utilizes potable water to cool its boilers, although that water must be demineralized at additional cost to avoid damaging the plant's turbines; and

WHEREAS, recycled water is produced at the Board of Water Supply's Honouliuli Water Recycling Facility (HWRF) in Ewa to provide a reliable source of non-potable water for irrigation and industrial uses that is safe for the environment and more advantageous to use than potable water sources; and

WHEREAS, located at the property line of the H-Power facility is the HWRF pipeline that transmits reverse osmosis (RO) recycled water for industrial purposes; and

WHEREAS, the HWRF is designed to generate a total of 2 million gallons per day of RO recycled water; and

WHEREAS, the council understands that there may be a sufficient quantity of RO recycled water from HWRF to supply H-Power's needs via the neighboring pipeline; now, therefore,

BE IT RESOLVED by the Council of the City and County of Honolulu that it expresses its support for the use of RO recycled water by H-Power; and

BE IT FURTHER RESOLVED that the director of the department of environmental services and the director and chief engineer of the board of water supply are urged to implement H-Power's use of RO recycled water at the earliest feasible opportunity; and
